## TERMS & CONDITIONS:-

1. This Permanent Recognition is granted on the condition that the documents information furnished by the school authority are factual and not devoid in any way.
2. The school shall follow the course of the study as per the syllabus of the affiliated board.
3. The school will charge fee and funds as declared to appropriate authority at the time of the application for recognition and the same shall be displayed on the notice board of the school and school shall not increase the fee during the academic session. In case of increase in fee structure the school will inform the appropriate authority in the month of January for the next session and will also issue the receipts for the same to students.
4. Salary shall be paid as per declaration at the time of seeking recognition.
5. No capitation fee or other charges will be charged from the children and parents.
6. School shall be open for the inspection officers of the appropriate authority.
7. Managing Committee will not allow to run two affiliated schools in the same premises.
8. Managing Committee shall not close down the school or existing class during the academic session without prior permission of appropriate authority.
9. Recognition granted would be renewed after every 10 years.
